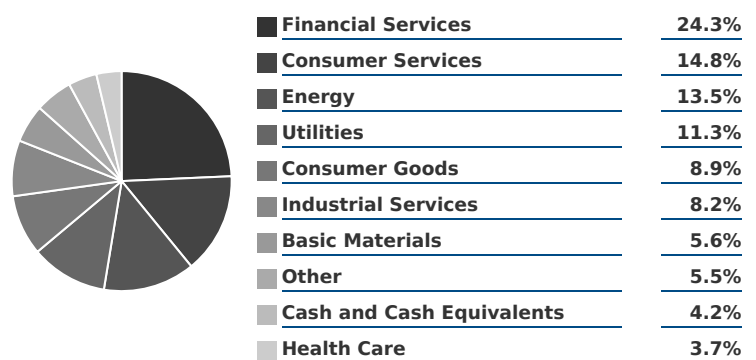

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

CI Investments Inc. has rated the volatility of this fund as medium.

Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

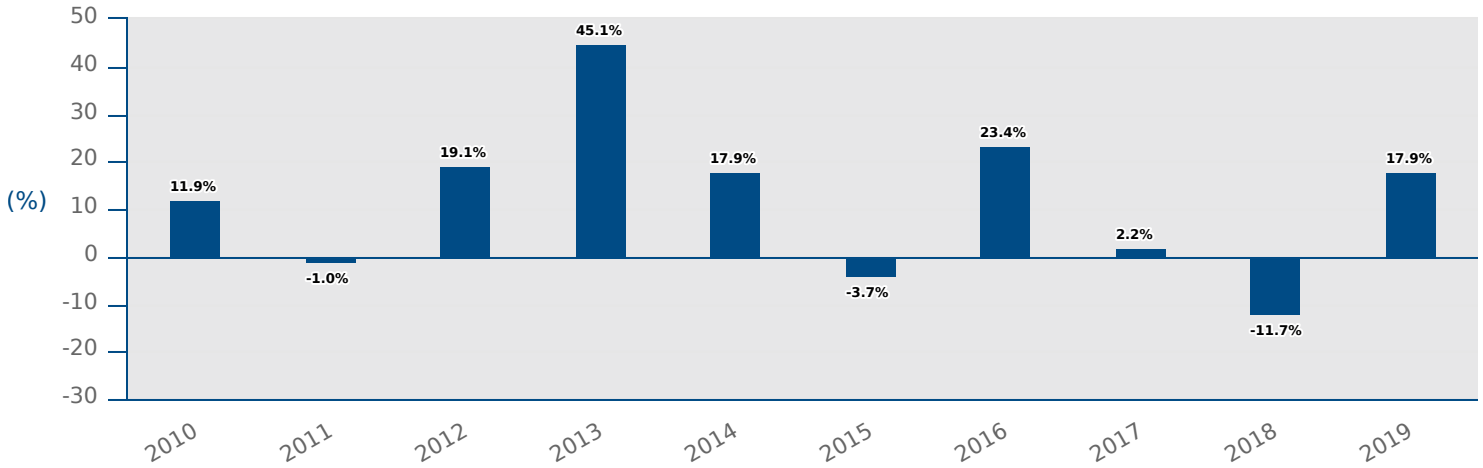
# Canadian Equity Growth Corporate Class (Series E shares)

## How has the fund performed?

This section tells you how Series E securities of the fund have performed over the past 10 calendar years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

### Year-by-year returns

This chart shows how Series E securities of the fund performed in each of the past 10 calendar years. This fund series dropped in value in 3 of the last 10 calendar years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series E securities of the fund in a 3-month period over the past 10 calendar years to May 31, 2020. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

The annual compounded return of Series E securities of the fund was 9.3% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would now be worth \$2,427.

## Who is this fund for?

### This fund may be suitable for you if you:

- want a medium risk investment focused on generating capital growth
- are planning to hold your investment for the medium and/or long term

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws of where you live and whether you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series E securities of the fund. The fees and expenses — including any commissions — can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You may have to choose a sales charge option when you buy this fund series. Ask about pros and cons of each option.

Any standard deferred sales charge you pay when you sell the fund goes to us.</li> <li>You can sell up to 10% of your securities each year without paying a standard deferred sales charge subject to certain restrictions ("10% free redemption right"). Your 10% free redemption right is reduced by the equivalent number of securities you would have received if you had reinvested any cash distributions you received during the calendar year. If you exercised your 10% redemption right and redeem your securities before the standard deferred sales charge schedule has expired, your standard deferred sales charge on a full redemption would be the same as if you had not redeemed securities under your 10% free redemption right.</li> <li>If you hold the fund in a non-registered account, if applicable, you can ask to receive cash distributions which are not subject to standard deferred sales charges.</li> <li>You can switch between standard deferred sales charge funds at any time without paying this sales charge. The standard deferred sales charge schedule will be based on the date you bought securities of the first fund and the rates and duration of such schedule shall continue to apply.</li> <li>Your securities will be converted into the initial sales charge option after the expiry of the standard deferred sales charge schedule if you qualify for Preferred Pricing (and if available for your securities), and such securities will participate in the program.</li> </ul>

<b>If you sell within:</b>		<ul style="list-style-type: none"> <li>The intermediate deferred sales charge is a set rate and is deducted from the amount you sell based on the initial cost and number of those securities.</li> <li>When you buy the fund, we pay your representative's firm a commission of 4%. Any intermediate deferred sales charge you pay when you sell the fund goes to us.</li> <li>You can sell up to 10% of your securities each year without paying an intermediate deferred sales charge subject to certain restrictions. Your 10% free redemption right is reduced by the equivalent number of securities you would have received if you had reinvested any cash distributions you received during the calendar year. If you exercised your 10% redemption right and redeem your securities before the intermediate deferred sales charge schedule has expired, your intermediate deferred sales charge on a full redemption would be the same as if you had not redeemed securities under your 10% free redemption right.</li> <li>If you hold the fund in a non-registered account, if applicable, you can ask to receive cash distributions which are not subject to intermediate deferred sales charges.</li> <li>You can switch between intermediate deferred sales charge funds at any time without paying this sales charge. The intermediate deferred sales charge schedule will be based on the date you bought securities of the first fund and the rates and duration of such schedule shall continue to apply.</li> <li>Your securities will be converted into the initial sales charge option after the expiry of the intermediate deferred sales charge schedule if you qualify for Preferred Pricing (and if available for your securities), and such securities will participate in the program.</li> </ul>

<b>If you sell within:</b>		<ul style="list-style-type: none"> <li>The low-load sales charge is a set rate and is deducted from the amount you sell based on the initial cost and number of those securities.</li> <li>When you buy the fund, we pay your representative's firm a commission of up to 2.5%. Any low-load sales charge you pay when you sell the fund goes to us.</li> <li>If you hold the fund in a non-registered account, if applicable, you can ask to receive cash distributions which are not subject to low-load sales charges.</li> <li>You can switch between low-load sales charge funds at any time without paying this sales charge. The low-load sales charge schedule will be based on the date you bought securities of the first fund and the rates and duration of such schedule shall continue to apply.</li> <li>Your securities will be converted into the initial sales charge option after the expiry of the low-load sales charge schedule if you qualify for Preferred Pricing (and if available for your securities), and such securities will participate in the program.</li> </ul>

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund series' returns. As of March 31, 2020, the total fund series' expenses were 2.43%. This equals \$24.30 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the fund series' management fee (which includes the trailing commission), administration fee, and Certain Fund Costs.	2.36%

### More about trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

CI Investments Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

<b>Intermediate deferred sales charges</b>	0% to 0.65% of the value of your investment each year	\$0 to \$6.50 each year on every \$1,000 invested
<b>Low-load sales charges</b>	0% to 0.50% of the value of your investment each year	\$0 to \$5.00 each year on every \$1,000 invested

The standard and intermediate deferred sales charge trailing commission rates, and the low-load sales charge trailing commission rate, each changes to the initial sales charge trailing commission rate upon completion of your deferred sales charge schedule.

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	Up to 2% of the net asset value of the securities you redeem, if we determine that you have engaged in inappropriate short-term trading. This fee goes to the fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2% of the net asset value of securities you switch to another fund.
<b>Program minimum fee</b>	If you participate in one of our managed programs, we may charge you an annual fee of up to 0.15% of the net asset value of the applicable series of securities of the fund within the program, payable to us quarterly by the redemption of securities (without charges), if your investment is less than the program minimum.
<b>Reclassification fee</b>	If you are switching Series A, E, ET8, or W securities to Series F, FT8, I, IT8 or OF securities of a fund, you may have to pay us a reclassification fee if you bought your securities under a Deferred Sales Charge Option. The reclassification fee is equal to the redemption fee you would pay if you sold such securities.
<b>NSF cheque fee</b>	There is a \$25 charge for all cheques returned because of insufficient funds.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the limit set by the securities law in your province or territory.
