**What does the fund invest in?**

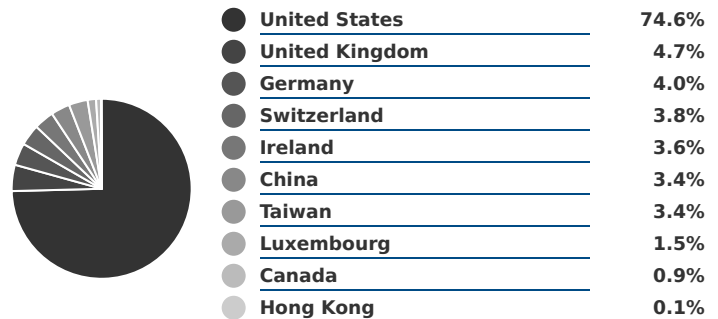
The primary investment objective of the fund is to provide long-term capital growth by investing primarily in equity and equity-related securities anywhere in the developed or developing world.

**How risky is it?**

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

**Risk rating**

CI Global Asset Management has rated the volatility of this fund as **medium**.

Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

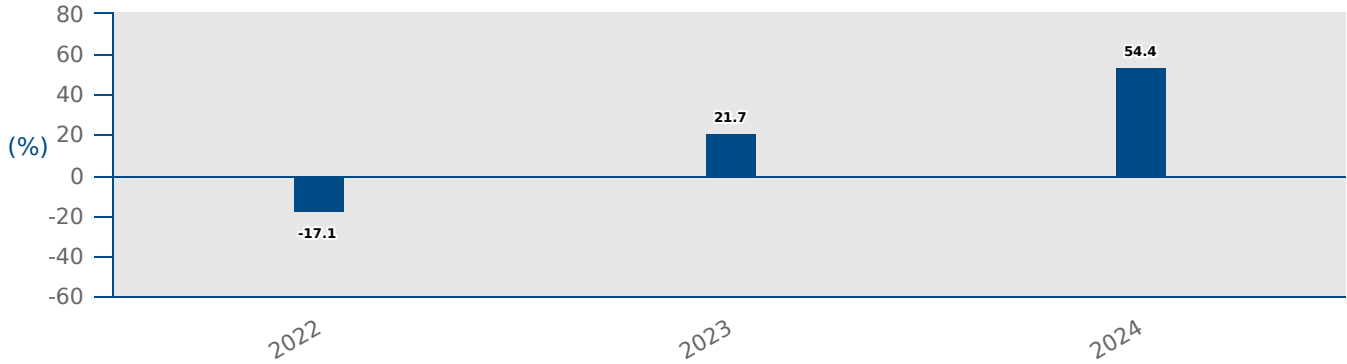
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the fund performed?

This section tells you how Series W securities of the fund have performed over the past 3 calendar year(s). Returns are after expenses have been deducted. These expenses reduce the fund's returns.

### Year-by-year returns

This chart shows how Series W securities of the fund performed in each of the past 3 calendar year(s). This fund series dropped in value in 1 of the last 3 calendar year(s). The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series W securities of the fund in a 3-month period over the past 3 calendar year(s). The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

As at May 31, 2025, a person who invested \$1,000 in Series W securities of the fund since inception has \$1,804. This works out to an annual compounded rate of return of 14.9%.

## Who is this fund for?

### This fund may be suitable for you if you:

- want a medium risk investment that is focused on generating capital growth
- are planning to hold your investment for the medium and/or long term

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws of where you live and whether you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

# Global Equity Pool (Series W units)

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series W securities of the fund. The fees and expenses — including any commissions — can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You can only buy Series W securities of the fund under the initial sales charge option. However, you can switch to Series W securities of the fund under the standard deferred sales charge option or intermediate deferred sales charge option if such option(s) are available and you are switching from securities under such option(s) of a fund managed by us. The deferred sales charge schedule will be based on the date you bought the first fund, and the rates and duration of such schedule shall continue to apply.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund series' returns. As of December 31, 2024, the total fund series' expenses were 0.36%. This equals \$3.60 for every \$1,000 invested.

### More about trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

CI Global Asset Management pays the trailing commission to your representative's firm. It is paid from the base fee and Optima Strategy Asset Management Service (AMS) fee and is based on the value of your investment. The rate depends on the sales charge option you hold and whether you use the AMS.

Each deferred sales charge trailing commission rate changes to the ISC trailing commission rate upon completion of your deferred sales charge schedule.

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	Up to 2% of the net asset value of the securities you redeem, if we determine that you have engaged in inappropriate short-term trading. This fee goes to the fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2% of the net asset value of securities you switch to another fund.
<b>Base fee</b>	You will be charged an annual base fee of up to a maximum of 2.50% and payable to us by the monthly or quarterly redemption of securities (without charges). This fee is calculated based on the net asset value of Series W securities of the fund in your account.
<b>Optima Strategy Asset Management Service (AMS) fee</b>	If you use the Optima Strategy asset management service, you will pay an AMS fee to us based on the net asset value of the fund in your account and payable to us by the monthly or quarterly redemption of securities (without charges), up to an annual maximum of 1.00% (negotiable) for initial sales charge securities and 0.50% (non-negotiable) for deferred sales charge securities.
<b>Reclassification fee</b>	If you are switching Series A, E, ET8, or W securities to Series F, FT8, I, IT8 or OF securities of a fund, you may have to pay us a reclassification fee if you hold your securities under a deferred sales charge option. The reclassification fee is equal to the redemption fee you would pay if you redeemed such securities.
<b>NSF cheque fee</b>	There is a \$25 charge for all cheques returned because of insufficient funds.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the limit set by the securities law in your province or territory.
